DRAFT RESOLUTION

RESOLUTION TO APPROPRIATE FUNDS TO THE TOWN OF PARMA FARMLAND RESERVE FUND

Motion for the following: The Town's chief fiscal officer is hereby directed to deposit the sum of \$10,000.00 from the Town's unappropriated B fund balance and secure the moneys of the Town of Parma Farmland/Open Space Reserve Fund (hereinafter "Farmland Reserve Fund") in the manner provided by Section 10 of the General Municipal Law. The chief fiscal officer may invest the moneys in the Farmland Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the investment policy of the Town. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve Fund. The chief fiscal officer shall account for the Farmland Reserve Fund in a manner which maintains the separate identity of the Farmland Reserve Fund and shows the date and amount of each sum paid into the fund, interest earned by the fund, capital gains or losses resulting from the sale of investments of the fund, the amount and date of each withdrawal from the fund and the total assets of the fund, showing cash balance and a schedule of investments, and shall, at the end of each fiscal year, render to the Board a detailed report of the operation and condition of the Farmland Reserve Fund.

Except as otherwise provided by law, expenditures from this Farmland Reserve Fund shall be made only for the purpose for which the Farmland Reserve Fund is established. No expenditure shall be made from this Farmland Reserve Fund without the approval of this governing board and such additional actions or proceedings as may be required by Section 6-c of the General Municipal Law or any other law.

This resolution shall take effect immediately.
